Pool Play:

4-Team Pool: Three 21 point sets (start at 4 points), no cap. Third set switch at 13.

5-Team Pool: Two 21 point sets (start at 4 points), no cap.

Work Teams:

1 Score Keeper, 1 Flipper, 1 Libero Tracker/Asst Score Keeper, 2 Line Judges, 2nd Referee.

Playoff Brackets:

Top 2 teams from each pool based on total wins. Ties will be resolved based on the current KRVA Junior Operating Code.

Work Teams for Semi-Final Matches:

Losers of last set of final pool play match on that court. If loser is in playoff, then winner of last set/match will be work team. If both teams are in the playoff, then the work team from the last pool match will work. If there is a Tie-Breaker match, this will be the work team for the Tie-Breaker and the Tie-Breaker Match will constitute the final pool play match for the purposes of determining a work team for the Semi-Final Matches.

Work Team for Final Match:

Loser of Semi-final with least travel time. You must see the Tournament Director before leaving. Mapquest/Mappoint travel time to Club representative's address/city will be determining factor.

Semi-Final & Final Matches:

Best 2 of 3 sets. Sets 1 & 2 to 25 points. Deciding Set to 15 points, switch at 8. All sets will start at 0 points. No Cap. KRVA Sunday rules apply for Sunday Tournaments.

Sunday Tournament Restrictions

Any Sunday Junior Tournament that has not concluded pool play before 7 PM will have all 'Quarter-Final' and 'Semi Final' matches consist of only one (1) set to 25 points with the teams switching sides at 13 points. Also, the 'Finals' of any Sunday Junior Tournament that has not concluded all 'Semi-final' matches by 8 PM will have only one (1) 'Final' set to 25 points, with the teams switching sides at 13 points.

Should any Tournament Director find that their Event will fall under this Rule the Director may choose to either follow the Rule as written OR take a vote of the remaining competing teams as to their desire to follow the Rule or continue play as previously scheduled. Should any ONE (1) team wish to follow the Rule, then the Tournament Director will revise their Event to match the play schedule as outlined by this Rule.
